

RESOLUTION NO. 85-33J

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF RALPH AND DIANNE HERBERT FOR A ZONING DISTRICT BOUNDARY CHANGE FROM A-1 DISTRICT TO R-R 10 DISTRICT FOR 9.66 ACRES, MORE OR LESS, IN THE E1/2NE1/4, AND LOT 7 (NE1/4SE1/4) OF SECTION 15, T30N, R110W, SUBLLETTE COUNTY, WYOMING.

WHEREAS, Ralph and Dianne Herbert filed application with the Sublette County Planning and Zoning Commission to reclassify and rezone 10 acres, more or less, from A-1 district to R-R 10 district in the E1/2NE1/4, and Lot 7 (NE1/4SE1/4) of Section 15, T30N, R110W, Sublette County, Wyoming;

WHEREAS, a notice of public hearing on said application before said Commission was published in the Pinedale Roundup on May 23 and June 20, 1985;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before the said Planning and Zoning Commission at 7:30p.m. on June 27, 1985, at which time said Commission determined it would recommend to the Board of County Commissioners of Sublette County that the application be approved;


WHEREAS, a notice of public hearing on said application before the Board of County Commissioners of Sublette County was published in the Pinedale Roundup on June 27, 1985;
