

RESOLUTION NO. 85-43J

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF CHARLES O. AND ALICE F. FULLER FOR A ZONING DISTRICT BOUNDARY CHANGE FROM A-1 DISTRICT TO RM DISTRICT FOR 9.91 ACRES, BEING LOT 5, SHRIVER SUBDIVISION OF RECORD IN THE OFFICE OF THE CLERK OF SUBLETTE COUNTY, WYOMING.

WHEREAS, Charles O. and Alice F. Fuller filed application with the Sublette County Planning and Zoning Commission to reclassify and rezone 9.91 acres, from A-1 district to RM district being Lot 5, Shriver Subdivision of Record in the Office of the Clerk of Sublette County, Wyoming;

WHEREAS, a notice of public hearing on said application before said Commission was published in the Pinedale Roundup on June 20 and July 18, 1985;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before the said Planning and Zoning Commission at 7:30 p.m. on July 25, 1985, at which time said Commission determined it would recommend to the Board of County Commissioners of Sublette County that the application be approved;

WHEREAS, a notice of public hearing on said application before the Board of County Commissioners of Sublette County was published in the Pinedale Roundup on August 1, 1985;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before said Board of County Commissioners at 1:00 p.m. on August 20, 1985, at which time said Board determined that it would accept and follow the recommendation of the Planning and Zoning Commission and approve said application.

NOW, THEREFORE, BE IT RESOLVED:

That the application of Charles O. and Alice F. Fuller to reclassify and rezone 9.91 acres, from A-1 district to RM district being Lot 5, Shriver Subdivision of Record in the Office of the Clerk of Sublette County, Wyoming, is hereby approved.
