

RESOLUTION NO. 86-73J

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION BY DON ANSELMI FOR A ZONING DISTRICT BOUNDARY CHANGE FROM A-1 DISTRICT TO R-R 20 DISTRICT FOR 23.4 ACRES, MORE OR LESS, BEING PART OF LOT 2 (NW1/4NE1/4), SECTION 4, T34N, R110W, LYING AND BEING SITUATE EASTERLY OF THE CENTER-LINE OF STATE HIGHWAY 352, EXCEPTING THEREFROM THE W1/2NE1/4 AS PATENTED TO THE COUNTY OF SUBLINTE OF RECORD IN THE OFFICE OF THE CLERK OF SUBLINTE COUNTY IN BOOK 4 OF PATENTS ON PAGE 53.

WHEREAS, a notice of public hearing on said application before the Board of County Commissioners of Sublette County was published in the Pinedale Roundup on February 27, 1986;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before said Board of County Commissioners at 1:00 p.m. on March 18, 1986, at which time said Board determined it would approve said application.


NOW, THEREFORE, BE IT RESOLVED:
