

RESOLUTION NO. 86-80J

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF TIMOTHY S. AND MARGARET M. BOHAN FOR A ZONING DISTRICT BOUNDARY CHANGE TO RECLASSIFY AND REZONE 10 ACRES, MORE OR LESS, FROM AGRICULTURAL (A-1) DISTRICT TO RURAL RESIDENTIAL 5 (R-R 5) DISTRICT BEING THE SW1/4SE1/4SW1/4, SECTION 3, T34N, R110W, SUBLETTE COUNTY, WYOMING.

WHEREAS, Timothy S. and Margaret M. Bohan filed application with the Sublette County Planning and Zoning Commission to reclassify and rezone 10 acres, more or less, from agricultural (A-1) district to rural residential 5 (R-R 5) district being the SW1/4SE1/4SW1/4, Section 3, T34N, R110W, Sublette County, Wyoming;

WHEREAS, a notice of public hearing on said application before said commission was published in the Pinedale Roundup on March 13 and April 10, 1986;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before the said Planning and Zoning Commission at 7:30 p.m. on April 17, 1986, at which time said Commission determined it would recommend to the Board of County Commissioners of Sublette County that the application be approved;

WHEREAS, a notice of public hearing on said application before the Board of County Commissioners of Sublette County was published in the Pinedale Roundup on May 1, 1986;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before said Board of County Commissioners at 1:00 p.m. on May 20, 1986, at which time said Board determined it would accept the recommendation of the Planning and Zoning Commission and approve said application.

NOW, THEREFORE, BE IT RESOLVED:

That the application of Timothy S. and Margaret M. Bohan to rezone and reclassify 10 acres, more or less, from agricultural (A-1) to rural residential 5 (R-R 5) district being the SW1/4SE1/4SW1/4, Section 3, T34N, R110W, Sublette County, Wyoming, is hereby approved.
