RESOLUTION NO. 86-82J

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF HOWARD M. KNUTSON AND THOMAS A. GILBERTSON FOR A ZONING DISTRICT BOUNDARY CHANGE TO RECLASSIFY AND REZONE 18 ACRES, MORE OR LESS, FROM AGRICULTURAL (A-1) DISTRICT TO LIGHT INDUSTRIAL (I-L) DISTRICT BEING PART OF THE NE1/4NW1/4 AND N1/2NE1/4 OF SECTION 19 AND PART OF THE S1/2SE1/4 OF SECTION 18, T29N, R111W, SUBLINTE COUNTY, WYOMING.

WHEREAS, Howard M. Knutson and Thomas A. Gilbertson filed application with the Sublette County Planning and Zoning Commission to reclassify and rezone 18 acres, more or less, from agricultural (A-1) district to light industrial (I-L) district being part of the NE1/4NW1/4 and N1/2NE1/4 of Section 19 and part of the S1/2SE1/4 of Section 18, T29N, R111W, Sublette County, Wyoming;

WHEREAS, a notice of public hearing on said application before said Commission was published in the Pinedale Roundup on January 16 and April 10, 1986;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before the said Planning and Zoning Commission at 7:30 p.m. on April 17, 1986, at which time said Commission determined it would recommend to the Board of County Commissioners of Sublette County that the application be approved;

WHEREAS, a notice of public hearing on said application before the Board of County Commissioners of Sublette County was published in the Pinedale Roundup on May 1, 1986;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before said Board of County Commissioners at 1:00 p.m. on May 20, 1986, at which time said Board determined it would accept the recommendation of the Planning and Zoning Commission and approve said application.

NOW, THEREFORE, BE IT RESOLVED:

That the application of Howard M. Knutson and Thomas A. Gilbertson to rezone and reclassify 18 acres, more or less, from agricultural (A-1) to light industrial (I-L) district being part of the NE1/4NW1/4 and N1/2NE1/4 of Section 19 and part of the S1/2SE1/4 of Section 18, T29N, R111W, Sublette County, Wyoming, is hereby approved.
