

A RESOLUTION ESTABLISHING THE HOBACK RANCHES PROPERTY OWNERS
IMPROVEMENT AND SERVICE DISTRICT, SETTING BOUNDARIES AND
CALLING FOR AN ELECTION.

WHEREAS, on August 20th, 1985, a petition was filed with the commissioners for formation of an improvement and service district under the Improvement of Service District Act, Title 18, Chapter 12, Wyoming Statutes 1977, under the certificate of Hazer Werner, county assessor, certifying that the signatures affixed thereto constituted a number in excess of 60% of the owners of real property in the proposed district whose property would be subject to assessment, accompanied by a filing fee of \$200.00;

WHEREAS, on August 8, 1985, a notice of public hearing on the petition was published in the manner and for the time required by law, as evidenced by the publisher's affidavit attached hereto;

WHEREAS, pursuant to said notice, a public hearing was had on the petition on August 20, 1985, at the county commissioners' meeting room in Pinedale, Wyoming;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SUBLETTE COUNTY, WYOMING:

1. That the establishment of the proposed district would serve the public convenience and necessity in the area specified in the petition.
2. That the proposed district will be for the purpose of maintaining the perimeter fences around the boundary of the proposed district, of protecting the proposed district from hunters, and of maintaining roads located in the proposed district and road(s) leading from U.S. Highways' 187 and 189 to the boundary line of the proposed district.
3. That The Hoback Ranches Property Owners Improvement and Service District is hereby established.
4. That the boundaries of the district are set forth and described in the publisher's affidavit.
5. That a special election is hereby called to be held concurrent with the primary election on August 19, 1986, at which election the property owners resident within the said district shall vote whether or not the district shall be organized and shall vote on initial board of directors consisting of three persons, one to serve for three (3) years, one to serve for four (4) years, and one to serve for five (5) years, with subsequent elections to fill expired terms to be held beginning August 19, 1989, and continuing annually thereafter on the anniversary of the organizational election.
6. That the polling place for said election shall be the Bondurant schoolhouse, and that the time for said election shall be between the hours of 9:00 a.m. and 5:00 p.m., on August 19, 1986. Non-resident property owners within said district are authorized to vote by absentee ballot.
