

RESOLUTION NO. 86-89J

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF JAMES F. MICKELSON FOR A ZONING DISTRICT BOUNDARY CHANGE TO RECLASSIFY AND REZONE 30.5 ACRES, MORE OR LESS, FROM AGRICULTURAL (A-1) DISTRICT TO RURAL RESIDENTIAL 10 (R-R 10) DISTRICT BEING PART OF SECTIONS 3 AND 10, T30N, R112W, SUBLETTE COUNTY, WYOMING.

WHEREAS, James F. Mickelson filed application with the Sublette County Planning and Zoning Commission to reclassify and rezone 30.5 acres, more or less, from agricultural (A-1) district to rural residential mobile home 10 (R-R MH 10) district being that part of the SE1/4SW1/4, Section 3 and that part of the NW1/4NE1/4, Section 10, lying north and northeast of the right of way for County Road 23-143, all in T30N, R112W, Sublette County, Wyoming.

WHEREAS, a notice of public hearing on said application before said commission was published in the Pinedale Roundup on May 15 and June 12, 1986;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before the said Planning and Zoning Commission at 7:30 p.m. on June 19, 1986, at which time said Commission determined it would recommend to the Board of County Commissioners of Sublette County that the application be approved as amended to rezone and reclassify said 30.5 acres from A-1 district to R-R 10 district;

WHEREAS, a notice of public hearing on said application before the Board of County Commissioners of Sublette County was published in the Pinedale Roundup on June 26, 1986;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before said Board of County Commissioners at 1:00 p.m. on July 15, 1986, at which time said Board determined it would accept the recommendation of the Planning and Zoning Commission and approve said application.

NOW, THEREFORE, BE IT RESOLVED:

That the application of James F. Mickelson to rezone and reclassify 30.5 acres, more or less, from agricultural (A-1) district to rural residential 10 (R-R 10) district being that part of the SE1/4SW1/4, Section 3 and that part of the NW1/4NE1/4, Section 10, lying north and northeast of the right of way for County Road 23-143, all in T30N, R112W, Sublette County, Wyoming, is hereby approved.

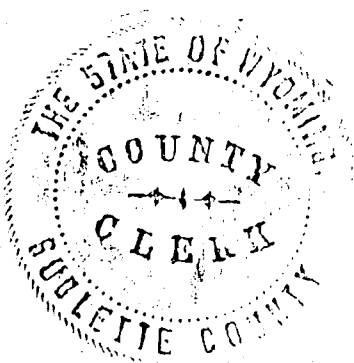
