

RESOLUTION NO. 86-91J

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION BY DONALD R. AND JUNE WASSENBERG TO RECLASSIFY AND REZONE 19.355 ACRES FROM AGRICULTURAL (A-1) TO RURAL RESIDENTIAL 10 (R-R 10) DISTRICT BEING PART OF SECTION 19, T30N, R111W, SUBLINTE COUNTY, WYOMING.

WHEREAS, Donald R. and June Wassenberg filed application with the Sublette County Planning and Zoning Commission to reclassify and rezone 19.355 acres, more or less, from agricultural (A-1) district to rural residential 10 (R-R 10) district being part of the SE1/4NE1/4, Section 19, T30N, R111W, Sublette County, Wyoming;

WHEREAS, a notice of public hearing on said application before said commission was published in the Pinedale Roundup on May 15 and June 12, 1986;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before the said Planning and Zoning Commission at 7:30 p.m. on June 19, 1986, at which time said Commission determined it would recommend to the Board of County Commissioners of Sublette County that the application be approved;

WHEREAS, a notice of public hearing on said application before the Board of County Commissioners of Sublette County was published in the Pinedale Roundup on June 26, 1986;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before said Board of County Commissioners at 1:00 p.m. on July 15, 1986, at which time said Board determined it would accept the recommendation of the Planning and Zoning Commission and approve said application.

NOW, THEREFORE, BE IT RESOLVED:

That the application of Donald R. and June Wassenberg to reclassify and rezone 19.355 acres, more or less, from agricultural (A-1) district to rural residential 10 (R-R 10) district being part of the SE1/4NE1/4, Section 19, T30N, R111W, Sublette County, Wyoming, is hereby approved.


