

RESOLUTION NO. 87-118T

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION BY PATRICK J. OTTOBRE AND NORMAN EVARTS FOR A ZONING DISTRICT BOUNDARY CHANGE TO RECLASSIFY AND REZONE 5.0 ACRES, MORE OR LESS, FROM R-R MH5 DISTRICT TO RM DISTRICT BEING PART OF SE1/4NW1/4, SECTION 30, T34N, R110W, SUBLETTE COUNTY, WYOMING.

WHEREAS, Patrick J. Ottobre and Norman Evarts filed application with the Sublette County Planning and Zoning Commission to reclassify and rezone from R-R MH5 District to RM District 5.0 acres, more or less, being part of SE1/4NW1/4, Section 30, T34N, R110W, Sublette County, Wyoming; and

WHEREAS, a notice of public hearing on said application before said Commission was published in the Pinedale Roundup on December 11, 1986, and January 8, 1987; and

WHEREAS, pursuant to said published notice, a public hearing on said application was had before the said Planning and Zoning Commission at 7:30 p.m. on January 15, 1987, at which time said Commission determined that it would recommend to the Board of County Commissioners of Sublette County that the application be approved; and

WHEREAS, a notice of public hearing on said application before the Board of County Commissioners of Sublette County was published in the Pinedale Roundup on January 29, 1987; and

WHEREAS, pursuant to said published notice, a public hearing on said application was had before said Board of County Commissioners at 1:00 p.m. on February 17, 1987, at which time said Board determined it would approve said application.

NOW, THEREFORE BE IT RESOLVED:

That the application of Patrick J. Ottobre and Norman Evarts to reclassify and rezone 5.0 acres, more or less, from R-R MH5 District to RM District being part of SE1/4NW1/4, Section 30, T34N, R110W, Sublette County, Wyoming, is hereby approved.
