

RESOLUTION NO. 86-102J

A RESOLUTION ADOPTING THE RECOMMENDATION OF THE PLANNING AND ZONING COMMISSION AND APPROVING THE APPLICATION OF JAMES LENT AND DOROTHY HECOX FOR A ZONING DISTRICT BOUNDARY CHANGE TO RECLASSIFY AND REZONE 45 ACRES, MORE OR LESS, FROM A-1 DISTRICT TO R-R 10 DISTRICT BEING PART OF SECTION 24, T37N, R110W, SUBLETTE COUNTY, WYOMING.

WHEREAS, James Lent and Dorothy Hecox filed application to reclassify and rezone from A-1 district to R-R 10 district 45 acres, more or less, being part of S1/2SE1/4NE1/4, NE1/4NE1/4SE1/4, SW1/4NE1/4SE1/4, NE1/4SW1/4SE1/4, Section 24, T37N, R110W, Sublette County, Wyoming;

WHEREAS, a notice of public hearing on said application before said Commission was published in the Pinedale Roundup on July 17 and August 14, 1986;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before the said Planning and Zoning Commission at 7:30 p.m. on August 21, 1986, at which time said Commission determined that it would recommend to the Board of County Commissioners of Sublette County that the application be approved;

WHEREAS, a notice of public hearing on said application before the Board of County Commissioners of Sublette County was published in the Pinedale Roundup on August 28, 1986;

WHEREAS, pursuant to said published notice, a public hearing on said application was had before said Board of County Commissioners at 1:00 p.m. on September 16, 1986, at which time said Board determined that it would accept and follow the recommendation of the Planning and Zoning Commission and approve said application.

NOW, THEREFORE, BE IT RESOLVED:

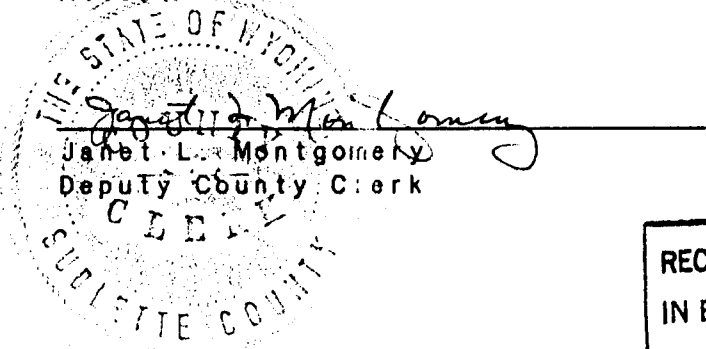
