THIS AMENDED CERTIFICATE ISSUED IN LIEU OF THE ORIGINAL CERTIFICATES OF RECORD IN CERTIFICATE RECORD 27, PAGE 302, AND CERTIFICATE RECORD 29, PAGE 4, AND TO CORRECT THE ORDER OF ADJUDICATION OF RECORD IN CERTIFICATE RECORD 27, PAGE 302, 127 AND 224, PROOFS 902 and 9342.

The right to water hereby confirmed and established is limited to irrigation and the use is restricted to the place where acquired and to the purpose for which acquired; rights for irrigation not to exceed one cubic foot of water per second for each seventy acres of land for which the appropriation is herein determined and established, except when there is surplus water in the stream as provided by Sections 41-189, Wyoming Statutes, 1957.
