

ORDER RECORD NO. 17 -STATE BOARD OF CONTROL

THE BOARD now being advised by the records of the Offices of the State Engineer and the State Board of Control and the showings presented in the matter, THEREFORE ORDERS:

THAT the petition, as corrected according to Paragraph 5, be GRANTED.

THAT an Amended Certificate of Appropriation be issued to Lester Pape and Son Ranches, Inc., as successor to Minnie F. and Charles A. Cox, the original appropriators, to correct the number of acres irrigated and amount of the appropriation in the original Certificate of record in Certificate Record 6, Page 66, and to correct the Order of record in Order Record 3, Page 278, Proof No. 5455, all in accordance with the following tabulation:
