

ORDER RECORD NO. 18-STATE BOARD OF CONTROL

3. That Little Sandy Grazing Association is the sole owner of all of the lands described herein, and of the appropriation of water attached thereto; except for SW¹/₄ Sec. 13 in the NW¹/₄ SE¹/₄ and NW¹/₄ Sec. 6, Township 29 North, Range 103 West, and NE¹/₄ Sec. 1, NW¹/₄ Sec. 2, SW¹/₄ Sec. 1, NW¹/₄ Sec. 2, SE¹/₄ Sec. 1, SW¹/₄ Sec. 2, and SE¹/₄ of Section 36, in Township 30 North, Range 104 West, which lands and the appropriations of water attached thereto are owned by the State of Wyoming and leased to Little Sandy Grazing Association, all as evidenced by the Certificate of the County Clerk of Sublette County, Wyoming, which Certificate is attached to the Petition and marked "Exhibit B".

the above sunny grazing Association does, by their petition, pursuant to said Stipulations, allocate and apportion the said total of 15.00 cubic feet per second of water as set out later in this Order.

THE BOARD now being advised by the records of the offices of the State Engineer and the State Board of Control, and the showings presented in the matter, THEREUPON CRIMES:

THAT this petition of Little Sandy Grazing Association be GRANTED.

and amended certificates of Appropriation BE ISSUED to Little Sandy Grazing Association, as successor to the original Appropriators, for the following-described appropriations of water from Little Sandy Creek, tributary of Big Sandy River, as set out in Petition previously described, and all in accordance with the following tabulation:
