AND ALLOCATION AND APPOINTMENT OF WATER RIGHTS UNDER EACH AND ALL OF SAID APPROPRIATIONS PURSUANT TO STIPULATION IN THE MATTER OF THE PETITION OF THE UNITED STATES BUREAU OF RECLAMATION FOR ABANDONMENT OF CERTAIN WATER RIGHTS LOCATED ALONG THE WATERWAY COMMONLY KNOWN AS THE LITTLE SANDY CREEK.

FINDINGS AND ORDER

THIS MATTER coming regularly before the State Board of Control this 15th day of May, 1970, the Board FINDS:

- 1. THAT under date of January 12, 1970, the Little Sandy Grazing Association, acting through Gary Zakotnik, its Vice-President, filed with the State Board of Control a Petition for Amended Certificate of Appropriation of certain appropriations of water as listed in the Heading of this Order; said Petition was prepared after the Little Sandy Grazing Association had heretofore entered into a Stipulation with the Bureau of Reclamation, Department of the Interior, United States of America, in the matter of the above Petition for Abandonment or Partial Abandonment of Certain Appropriations of Water from Little Sandy Creek, tributary of Big Sandy River, in which Stipulation the Little Sandy Grazing Association was given the sole right to allocate and apportion 2.50 cubic feet per second of water under the following rights and permits:
