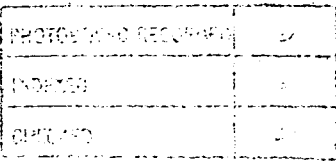

The right to water hereby confirmed and established is limited to irrigation and stock use. The use is restricted to the place where acquired and to the purpose for which acquired; rights for irrigation not to exceed one cubic foot of water per second, and for stock use not to exceed seventy acres of land for which the appropriation is herein determined and established, except when there is surplus water in the stream as provided by Sections 14-18, Wyoming Statutes, 1957.
