This matter was considered by the State Board of Control at its regular meeting on May 16, 1975, with the following results:

FINDINGS OF FACT

1. THAT the Board of Control has jurisdiction both to consider the petitioner's requests for change in point of diversion and means of conveyance for part and for voluntary abandonment for part, and to prepare and promulgate the order hereinafter set forth disposing of said petitions.
2. THAT petitioner is owner of the lands involved as evidenced by certificate of ownership from the county clerk of Sublette County, Wyoming.
3. THAT the appropriations involved all divert from West Fork New Fork River, tributary New Fork River through the Last Chance Ditch as follows:

a. The Theodore Tregoning Appropriation, Permit No. 3999, adjudicated as from New Fork River, priority June 23, 1902; and of record in Order Record 4, Page 128; Certificate Record 27, Page 311, Proof No. 9010, for irrigation of the following lands:
