IN THE MATTER OF THE PETITION FOR VOLUNTARY ABANDONMENT OF A PORTION OF THE MARY E. O'NEIL APPROPRIATION, PERMIT NO. 11079, DIVERTING FROM SOUTH PINEY CREEK, A TRIBUTARY OF THE GREEN RIVER THROUGH THE O'NEIL DITCH, AS CHANGED IN PART TO THE TARTER DITCH AND THENCE CHANGED FOR A PORTION TO THE REARDON DITCH AND CHANGED FOR A PORTION TO THE MIDMERMAC DITCH, WITH A PRIORITY OF NOVEMBER 23, 1911. (O.R. 5, P. 45; C.R. 36, P. 399; PROOF NO. 13198)

This matter was considered by the State Board of Control at its regular meeting on March 15, 1984 with the following results:

FINDINGS OF FACT

1. THAT the petitioners are the owners of the lands for which abandonment is sought as evidenced by Certificates of Ownership from the County Clerk of Sublette County, Wyoming.
2. THAT the appropriation involved is the Mary E. O'Neil appropriation, Permit No. 11079, adjudicated under Proof No. 13198, in the amount of 4.82 c.f.s. for the irrigation of 337.46 acres and diverting from South Piney Creek, which is a tributary of the Green River through the O'Neil Ditch as changed in part to the Tartar Ditch, thence changed for a portion to the Reardon Ditch and for a portion to the Midmermac Ditch, with a priority of November 23, 1911 and of record in Order Record 5, page 45; Certificate Record 36, page 399 describing the lands irrigated as follows:
