This matter was considered by the State Board of Control at its regular meeting on March 7, 1985, with the following results:

FINDINGS OF FACT

1. THAT the petitioner is the owner of the appropriation involved as evidenced by a Certificate of Ownership from the County Clerk of Sublette County, Wyoming.

2. THAT the appropriation involved is the C. G. Jewett appropriation, Permit No. 3528 Enl., adjudicated under Proof No. 20124 in the amount of 2.31 c.f.s. for stock purposes and for the irrigation of 162.0 acres, and diverting from Cottonwood or Marsh Creek, a tributary of the Green River through the Enlarged Bryan Ditch with a priority of January 5, 1916, and of record in Order Record 7, page 387; Certificate Record 47, page 50, describing the lands irrigated as follows:

3. THAT the petitioner stated that 28.0 acres of the C. G. Jewett appropriation were adjudicated in error as these acres should have been adjudicated as supplemental supply to Permit No. 10419, the Green River Supply Canal, diverting from the Green River with a priority of January 28, 1910. Therefore, the petitioner requested that the C. G. Jewett appropriation be amended as follows:
