This matter was considered by the State Board of Control at its regular meeting on August 19, 1986 with the following results:

FINDINGS OF FACT

1. THAT certain co-petitioners are owners of the lands to which water rights are attached by secondary as evidenced by Certificates of Ownership and recorded Agreements for Deed from the County Clerk of Sublette County, Wyoming. That co-petitioner, Sublette County - County Commissioners, are owners of lands to which it is proposed to attach said secondary rights.

2. THAT the appropriation involved is the John W. Bloom appropriation, Permit No. 4954 Enl., a secondary appropriation, adjudicated under Proof No. 21555, in the amount of 2811.63 acre-feet for the irrigation of 816.3 acres, from water stored in Fremont Lake Reservoir, Permit Nos. 4453 Res. and 4465 Res., which is supplied from Pine Creek, a tributary of West Fork New Fork River, a tributary of the New Fork River, which is a tributary of the Green River and delivered through the Enlarged Colorado Ditch with priorities of September 15, 1931 and November 20, 1931 for the stored water and of record in Order Record 9, page 337, Certificate of Record 52, page 281, describing the lands irrigated at a rate of 3.44 acre-feet per acre as follows: (NOTE: Actual rate is 3.4443586 but for the purpose of this Order the figure of 3.44 acre-feet is being used.)
