 and telephone lines.

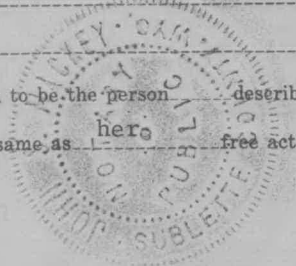
