KNOW ALL MEN BY THESE PRESENTS:

That M. F. Whelan Livestock Co., a Wyoming Corporation, hereafter called "Grantor," for and in consideration of the sum of One Dollar (\$1.00) cash in hand paid, and other good and valuable considerations, the receipt of which is hereby acknowledged, does hereby grant, bargain, sell, convey, transfer, assign and deliver unto Joseph P. Whelan, of Joliet, Montana, hereinafter called "Grantee," an undivided one-sixth (1/6) interest in and to all oil, gas and other minerals in and under, and that may be produced from the following described lands, situate in Lincoln and Sublette Counties, State of Wyoming, to-wit:

Lot Seven (7) and the Southwest Quarter of the Southeast Quarter (SW $\frac{1}{4}$ -SE $\frac{1}{4}$) of Section Twenty-nine (29); Lot One (1); the Northwest Quarter of the Southwest Quarter (NW $\frac{1}{4}$ -SW $\frac{1}{4}$); the West Half of the Northwest Quarter (W $\frac{1}{2}$ -NW $\frac{1}{4}$); the East Half of the West Half (E $\frac{1}{2}$ -W $\frac{1}{2}$), and the West Half of the East Half (W $\frac{1}{2}$ -E $\frac{1}{2}$) of Section Thirty-two (32), all in Township Twenty-seven (27) North, Range One Hundred Twelve (112), West of the 6th P.
