 in hand paid, receipt whereof is hereby acknowledged, CONVEY AND WARRANT TO V. L. Looney and
 Robert W. Sievers as tenants in common,

grantee S., of Sublette County and State of Wyoming
 the following described real estate, situate in Sublette County and State
 of Wyoming, hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the State,
 to-wit:

That portion of the $W\frac{1}{2}$ of the $NW\frac{1}{4}$ of Section 15, Township 34 North,
 Range 110 West of 6th P.M., Wyoming, lying west of the Cora Road,
 being West of the hereinafter described line to-wit: Beginning at
 a point on the south boundary of the $W\frac{1}{2}NW\frac{1}{4}$ of said Section 15 from
 from which the west quarter corner of said Section 15 bears due west
 a distance of 275.0 feet; thence North $17^{\circ}55'$ East a distance of
 1450.4 feet to the point of beginning of a $1^{\circ}00'$ curve to the left,
 the radius of which is 5729.6 feet, the total central angle of
 which is $16^{\circ}33'$ and the total length of which is 1655.0 feet;
 thence along said $1^{\circ}00'$ curve to the left through a central angle

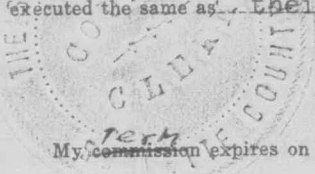
