the following described real estate, situate in Sublette County and State of Wyoming, hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the State, to-wit:

That portion of the N 1/2 NW 1/4, Section 25, Township 32 North, Range 108 West of the 6th P.M., Wyoming, described as follows:

Beginning at the northwest corner of Section 25, Township 32 North, Range 108 West, 6th P.M., Sublette County, Wyoming,

thence 808.8' south to a point on the west section line of Section 25,

thence North 44°42' East a distance of 440.3 feet,

thence North 67°17' East a distance of 572.2 feet,

thence South 65°58' East a distance of 296.1 feet,

thence South 34°10' East a distance of 236.1 feet,

thence South 48°55' East a distance of 100.0 feet,

thence South 88°01' East a distance of 100.0 feet,
