 existing under the laws of the State of Utah, Party of the First Part, and

W I T N E S S E T H

WHEREAS, the decree of dissolution has not been presented to the court or signed by said court or the judge thereof; and

WHEREAS, the Party of the Second Part, said Annie Laura Chesney, now holds in her own right 59,998 shares of the capital stock issued and outstanding of said corporation and has a contract to purchase the remaining two shares of stock outstanding.

NOW, THEREFORE, the Party of the First Part, said American Holding Company, in consideration of One Dollar (\$1.00) and other valuable considerations to it paid by the Party of the Second Part, said Annie Laura Chesney, the receipt of which is hereby acknowledged, does by these presents grant, bargain, sell, convey and confirm unto the Party of the Second Part, said Annie Laura Chesney, her executors, administrators and assigns, the following described tract of land lying, being and situated in the City of Salt Lake, County of Salt Lake and State of Utah, to wit:

Beginning at a point 85 feet South the Northwest corner of Lot 5, Block 50, Plat "B," Salt Lake City survey, and running thence East 155.25 feet; thence South 74 feet; thence West 155.25 feet; thence North 74 feet to the point of beginning. Together
