Robert W. Sievers and Donna E. Sievers, husband and wife,

grantor S, of Sublette County, and State
of Wyoming, for and in consideration of Ten and no/100 (\$10.00) Dollars
and other valuable consideration— DOLLARS

in hand paid, receipt whereof is hereby acknowledged, CONVEY AND WARRANT TO
William J. Thomas and Bertha W. Thomas, husband and wife, as tenants
of an estate by the entireties with full right of survivorship,

grantee S, of Sublette County and State of Wyoming
the following described real estate, situate in Sublette County and State
of Wyoming, hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the State,
to-wit:

SE $\frac{1}{4}$ NE $\frac{1}{4}$, SE $\frac{1}{4}$, Section Nine (9); T. 35 N., R.
111 West and the SW $\frac{1}{4}$ Section Nine (9); T. 35 N.
R111.W.6th P.M., except two tracts:
(1) That part of NW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 9; T. 35 N., R.
111 W., 6th P.M. more particularly described as
follows: Beginning at a point which is 570 feet
South of a point which is 1002 feet East of the
West Quarter Corner of Section 9; T. 35 N., R. 111 W.,
and running thence South 200 feet; thence East 400 feet;
thence North 200 feet; thence West 400 feet to point of
beginning.
(2) A part of NW $\frac{1}{4}$ SW $\frac{1}{4}$ Section 9, T. 35 N., R. 111 W.,
described as follows: Beginning on a point which is
400 feet South of a point which is 660 feet east of
the West quarter corner Section 9; T. 35 N., R. 111 W.,
6th P.M. and running thence South 510 feet; thence
N. 42° 40' W. 693.5 feet; thence East 470 feet to point
of beginning.

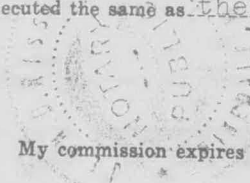
