 ft. to a point on the East R/W line of the Highway to Cora, Wyoming; thence N 60°52' West,

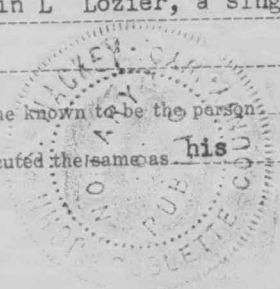
