husband and wife,



of Wyoming, hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the State,
to-wit:

One thousand acre feet storage water stored in Fremont Lake Reservoir,
tributary to Pine Creek, tributary of West Fork of the New Fork River,
tributary of New Fork River, under Permit No. 4954 En., Certificate Record
No. 52, page 281, filed in Office of County Clerk, Sublette County, Wyoming,
and recorded in Book 1 of Certificates of Appropriation, page 126, said
storage water to be conveyed through Enl. of Lee (Pine Creek #1) Ditch
and to be used upon the following described real property, situated in
