GRANT DEED

JESSIE G. FARGHER, a widow, for and in consideration of Ten Dollars to her in hand paid, receipt of which is hereby acknowledged, does hereby convey and warrant to JESSIE JEAN ROBBINS, a married woman, as her sole and separate property, the real property in the County of Sublette, State of Wyoming, described as follows:

Lot 2 and the Southeast quarter (SE $\frac{1}{4}$) of the Northwest quarter (NW $\frac{1}{4}$) of Section Seven (7), in Township Thirty-five (35) North, Range One Hundred Eleven (111) West;

The South Half (S $\frac{1}{2}$) of the Northeast quarter (NE $\frac{1}{4}$) of Section Twelve (12), in Township Thirty-five (35) North, Range One Hundred Twelve (112) West of the 6th P.M.;

The West one-half (W $\frac{1}{2}$) of the Southeast quarter (SE $\frac{1}{4}$) and the East one-half (E $\frac{1}{2}$) of the Southwest quarter (SW $\frac{1}{4}$) of Section Thirty-six (36), in Township Thirty-six (36) North, range One Hundred Twelve (112) West of the 6th P.M.;

Lots One (1), Two (2) and Three (3) and the Southwest quarter (SW $\frac{1}{4}$) of the Northeast quarter (NE $\frac{1}{4}$) of Section One (1), in Township Thirty-five (35) North, Range One Hundred Twelve (112) West of the 6th P.M.;

The West one-half (W $\frac{1}{2}$) of the Southeast quarter (SE $\frac{1}{4}$), and the East one-half (E $\frac{1}{2}$) of the Southwest quarter (SW $\frac{1}{4}$) of Section One (1), and the North one-half (N $\frac{1}{2}$) of the Northeast quarter (NE $\frac{1}{4}$) of Section Twelve (12), Township Thirty-five (35) North, Range One Hundred Twelve (112) West of the 6th P.M.;

The North one-half (N $\frac{1}{2}$), the East one-half (E $\frac{1}{2}$) of the Southeast quarter (SE $\frac{1}{4}$), and the West one-half (W $\frac{1}{2}$) of the Southwest quarter (SW $\frac{1}{4}$) of Section Thirti-six (36), Township Thirty-six (36) North, Range One Hundred Twelve (112) West of the 6th P.M.;

The South one-half (S $\frac{1}{2}$) of the Southwest quarter (SW $\frac{1}{4}$) and the Southwest quarter (SW $\frac{1}{4}$) of the Southeast quarter (SE $\frac{1}{4}$) of Section Twenty-five (25) in Township Thirty-six (36) North, Range One Hundred Twelve (112) West of the 6th P.M.;

Together with all improvements, water rights, water ditches, water appropriations to any and all of the above described property;

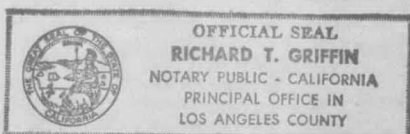
