for and in consideration of Ten dollars (\$10.00) and other valuable considerations Dollars  
in hand paid, convey and warrant to THE STATE HIGHWAY COMMISSION OF WYOMING, grantee, the follow-  
ing described real estate, situated in the County of Sublette, State of Wyoming, to-wit:

All that portion of the E $\frac{1}{2}$ E $\frac{1}{2}$  of Section 10, S $\frac{1}{2}$ SE $\frac{1}{4}$ , NW $\frac{1}{4}$ SE $\frac{1}{4}$ , SW $\frac{1}{4}$ NE $\frac{1}{4}$ , Lot 2 and  
Lot 3 of Section 3, T. 34 N., R. 111 W. of the 6th P.M., Wyoming, lying  
between parallel right of way lines of hereinafter stated distances apart when measured  
at right angles or radially to the following described survey line of highway, said  
parallel right of way lines beginning on the south boundary of said Section 10 and  
ending on the north boundary of said Section 3:

Beginning at a point on the south boundary of said Section 10 from which the south-  
east corner thereof bears N. 89° 39.5' E. a distance of 1,028.0 feet;  
thence with said parallel right of way lines 250 feet apart, being 100 feet to  
the left or westerly side and 150 feet to the right or easterly side, N. 2° 44.5' W. a  
distance of 3,860.3 feet to the point of beginning of a 1° 00' circular curve to the  
left, the radius of which is 5,729.6 feet;  
thence, continuing with said parallel right of way lines 250 feet apart, along  
said curve through a central angle of 10° 10' a distance of 1,016.7 feet to the point  
of ending of said curve;  
thence, continuing with said parallel right of way lines 250 feet apart, N. 12°  
54.5' W. a distance of 431.3 feet, more or less, to a point on the north boundary of  
said Section 10 from which the northeast corner thereof bears N. 89° 49.5' E. a distance  
of 1,410.9 feet;  
thence continuing with said parallel right of way lines 250 feet apart, continuing  
N. 12° 54.5' W. a distance of 1,867.7 feet;  
thence with said parallel right of way lines 300 feet apart, being 100 feet to the  
left or westerly side and 200 feet to the right or easterly side, continuing N. 12°  
54.5' W. a distance of 700.0 feet;  
thence with said parallel right of way lines 250 feet apart, being 100 feet to the  
left or westerly side and 150 feet to the right or easterly side, continuing N. 12°  
54.5' W. a distance of 2,004.0 feet to the point of beginning of a 0° 30' circular curve  
to the right, the radius of which is 11,459.2 feet;  
thence continuing with said parallel right of way lines 250 feet apart, along said  
curve through a central angle of 2° 28.8' a distance of 496.0 feet;  
thence with said parallel right of way lines 300 feet apart, being 100 feet to the  
left or westerly side and 200 to the right or easterly side, continuing along said  
curve through a central angle of 1° 25.6' a distance of 285.3 feet, more or less, to a  
point on the north boundary of said Section 3 from which the northeast corner thereof  
bears N. 89° 42.5' E. a distance of 2,554.7 feet.  
The above described parcel of land contains 60.2 acres, more or less.

Excepting and reserving from the above described lands and unto the grantors herein  
all oil, gas, minerals and mineral estate of every kind and nature that can be removed  
from the ground without jeopardy to the maintenance or safety of public travel upon the  
surface estate hereby granted and without using the surface of the lands hereby granted.

And said grantor.s hereby covenant with the State Highway Commission of Wyoming, that they are  
lawfully seized of said premises; that said premises are free from encumbrances, and said grantor.s hereby warrant  
the title thereto against the lawful claims of all persons whomsoever.

Hereby releasing and waiving any and all rights under and by virtue of the Homestead Exemption Laws of this State.
