for and in consideration of Ten dollars (\$10.00) and other valuable considerations Dollars  
in hand paid, convey and warrant to THE STATE HIGHWAY COMMISSION OF WYOMING, grantee, the following described real estate, situated in the County of Sublette, State of Wyoming, to-wit:

PARCEL NO. 1: All that portion of the NW $\frac{1}{4}$ NE $\frac{1}{4}$  of Section 10, T. 34 N., R. 111 W. of the 6th P.M., Wyoming, lying between the east boundary of said NW $\frac{1}{4}$ NE $\frac{1}{4}$  and a parallel right of way line 100 feet to the right or westerly side when measured at right angles or radially to the following described survey line of highway, said parallel right of way line beginning on the north boundary and ending on the east boundary of said NW $\frac{1}{4}$ NE $\frac{1}{4}$ :

Beginning at a point on the north boundary of said Section 10 from which the northeast corner thereof bears N. 89° 49.5' E. a distance of 1,410.9 feet; thence S. 12° 54.5' E. a distance of 431.3 feet to the point of beginning of a 1° 00' circular curve to the right, the radius of which is 5,729.6 feet; thence along said curve through a central angle of 0° 24' a distance of 40 feet, more or less, to a point on the east boundary of said NW $\frac{1}{4}$ NE $\frac{1}{4}$  from which the northeast corner thereof bears northerly a distance of 450 feet, more or less; thence continuing along said curve through a central angle of 6° 12' a distance of 620 feet, more or less, until said parallel right of way line 100 feet to the right or easterly side intersects said east boundary.

The above described parcel of land contains 2.1 acres, more or less.

PARCEL NO. 2: All that portion of the E $\frac{1}{2}$ W $\frac{1}{2}$ , W $\frac{1}{2}$ SE $\frac{1}{4}$  of Section 34, T. 35 N., R. 111 W. of the 6th P.M., Wyoming, lying between parallel right of way lines of hereinafter stated distances apart when measured at right angles or radially to the following described survey line of highway, said parallel right of way lines beginning on the north boundary and ending on the south boundary of said Section 34:

Beginning at a point on the north boundary of said Section 34 from which the north quarter corner thereof bears N. 89° 43.5' E. a distance of 596.8 feet; thence with said parallel right of way lines 250 feet apart, being 100 feet to the right or westerly side and 150 feet to the left or easterly side, S. 7° 43.5' E. a distance of 5,074.6 feet to the point of beginning of a 0° 30' circular curve to the left, the radius of which is 11,459.2 feet; thence continuing with said parallel right of way lines 250 feet apart, along said curve through a central angle of 0° 12.2' a distance of 40.7 feet; thence with said parallel right of way lines 300 feet apart, being 100 feet to the right or westerly side and 200 feet to the left or easterly side, continuing along said curve through a central angle of 1° 04.4' a distance of 214.7 feet, more or less, to a point on the south boundary of said Section 34 from which the southeast corner thereof bears N. 89° 42.5' E. a distance of 2,554.7 feet.

The above described parcel of land contains 30.9 acres, more or less.

Excepting and reserving from the above described lands and unto the grantors herein all oil, gas, minerals and mineral estate of every kind and nature that can be removed from the ground without jeopardy to the maintenance or safety of public travel upon the surface estate hereby granted and without using the surface of the lands hereby granted.
