WARRANTY DEED

THIS INDENTURE, made this 3rd day of May, 1970,
 by and between MILLER LAND AND LIVESTOCK COMPANY, a Corporation organized and
 existing under and by virtue of the laws of the State of WYOMING, and having its
 principal place of business in the County of Sublette, the GRANTOR, and MOUNTAIN
 FUEL SUPPLY COMPANY, a Utah Corporation of the County of Salt Lake, State of UTAH,
 the GRANTEE,

WITNESSETH: That the GRANTOR, for and in consideration of Ten and no/100
 - - - - DOLLARS (\$10.00) and other good and valuable considerations in hand paid,
 the receipt whereof is hereby acknowledged, does, by these presents, grant, bargain,
 sell, CONVEY AND WARRANT unto the said GRANTEE, all that certain tract, lot, piece,
 and parcel of land situate in Big Piney, County of Sublette, State of Wyoming, and
 described as follows:

That part of the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 36, T30N, R112W, Sublette County,
 Wyoming described as follows:

Beginning at a point on the south line of the incorporated limits of
 the Town of Big Piney, S65°-59'W, 1517.0 feet from the east one-quarter
 of said Section 36 where found a 2" galvanized steel pipe with brass
 cap inscribed "PAUL N. SCHERBEL RLS164 BIG PINEY WYOMING T30N 1/4
 R112W S36/R111W S31 1964" and S06°-24'W, 678.9 feet from the center
 east one-sixteenth corner of said Section 36 where found a quartzite
 stone 4"x8"x16" marked 1/16 on N, BP and S₅ on sides;
 thence N87°-32'W, 80.0 feet along the said south line and parallel
 to the south line of the Miller Addition to the Town of Big Piney;
 thence S00°-02'W, 40.0 feet to a point;
 thence S87°-32'E, 80.0 feet, parallel to the south line of said Miller
 Addition to a point;
 thence N00°-02'E, the base bearing for this survey, 40.0 feet to the
 point of beginning;
 each point being marked by a steel T-shaped stake 24" long with brass
 cap inscribed "SURVEY POINT DO NOT DISTURB RLS164";
