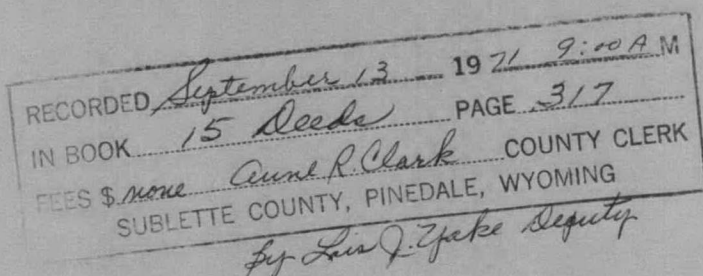


TAX DEED
