 of Wyoming, hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the State,

 County, Wyoming described as follows:

Beginning at the center one-quarter corner of said Section 4 where

 thence S. 89°-34'E., 427.1 feet along the north line of the


