in hand paid, receipt whereof is hereby acknowledged, CONVEY AND WARRANT TO DANIEL C. CARSON  
and CORRINE CARSON, Husband and Wife, as tenants of an estate by the  
entireties with full right of survivorship

grantee S., of Sublette County and State of Wyoming  
the following described real estate, situate in Sublette County and State  
of Wyoming, hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the State,  
to-wit:

An undivided 1/3 interest in and to the following:  
That portion of SE $\frac{1}{4}$ SW $\frac{1}{4}$  and SW $\frac{1}{4}$ SE $\frac{1}{4}$  Section 6, T. 33 N., R. 108 W.,  
which lies South of the center line of the County Road, a survey  
of said center line being described as follows: Beginning at a  
point on said County Road 970 feet South the Northwest corner of  
SE $\frac{1}{4}$ SW $\frac{1}{4}$  Sec. 6, T. 33 N., R. 108 W., and running thence along said  
center line, N. 72°43'E., 250 feet; thence N. 81°38'E., 640 feet;  
thence S. 86°58'E., 771 feet; thence S. 79°25'E., 769 feet;  
thence S. 78°32'E., 235 feet to the East boundary of SW $\frac{1}{4}$ SE $\frac{1}{4}$  of
