Grantees, the following described real estate situate in Sublette County, State
of Wyoming, hereby releasing and waiving all rights under and by virtue of the
homestead exemption laws of this state:

Boulder Lake Country Estates, First Filing, as depicted and described
on the plat thereof recorded in the Office of the County Clerk and Ex-
Officio Register of Deeds of Sublette County, Wyoming, on July 10,
1972, in Book 28 of Miscellaneous Records, at Page 239; being
platted over a portion of Homestead Entry No. 159, in Section 3,

W a distance of 811 feet to a point on a line between Corner No. 2
and Corner No. 3 of said H. E. S. No. 159 and is identical to the SE
Corner of Lot 23; thence N 79°45' W a distance of 425.00 feet to a

side of Bridger Drive; thence along the SE side of Bridger Drive a
